TransRe Announces Leadership Appointments Regional/Business Development Changes Will Support Continued Growth

Louise Rose Appointed Chief Executive of TransRe London Limited

With effect from September 1, 2019, subject to regulatory approval and as part of a planned succession strategy, Louise Rose will become Chief Executive Officer of TransRe London Limited (TransRe London).

Louise joined TransRe in 1997 from the National Vulcan Engineering Insurance Group. Her first role at TransRe was assistant underwriter, specializing in engineering and construction business. Over the course of her career at TransRe she has worked across multiple lines of business and, following roles of increasing responsibility, most recently as Head of Property, Aviation, Accident & Health and Engineering, ultimately being appointed Deputy CEO in 2017. In these roles Louise has been responsible for setting and executing the underwriting strategy, business planning, staff development and customer relationship management for TransRe London. In addition, she has been increasingly involved in regulatory and governance matters.

Kyle Rhodes Appointed Chief Executive of TransRe Asia Pacific

Kyle Rhodes will become Chief Executive of TransRe Asia Pacific. In this newly-created position, Kyle will be responsible for overseeing TransRe's four regional offices, and he will support the regional team as they develop and grow their customer and broker relationships in line with the opportunities as the region's economy develops and expands.

Kyle joined TransRe in 2006 from Employers Re. He formed and led the National & Specialty team at TransRe's US Custom division before leading that Division from 2012-2016. Most recently Kyle created and led TransRe's Business Development unit, where he concentrated on co-ordinating relationships with the largest global reinsurance buying groups.
