Description

The Underwriter will be exposed to many aspects of casualty liability (re)insurance, including General Liability, Automobile Liability, Umbrella and Excess. This position will report to the Senior Facultative officer within the Traditional Casualty Division. Responsibilities will include, but not be limited to:

- Handling all facets of Broker/Client management including marketing, negotiating and underwriting new and renewal accounts
- Evaluating complex risks associated with underwriting a casualty facultative book of business
- Assisting with managing the balance of the existing portfolio
- Conducting research and development of new reinsurance products within the Casualty space
