The Internship Program

- The program will be 10 weeks and will run from early June through early August
- Weekly work schedule will be 35 hours and follow a hybrid schedule, approximately 2-3 days in-office with the remainder remote. All interns will be in-office on Tuesdays and Wednesdays
- Internship will be paid in connection with the academic college year you will be entering in Fall 2023:
 - Freshman & Sophomores: \$23 / hour
 - Juniors & Seniors: \$25 / hour
- During the program, the intern group will attend a series of educational sessions to provide them with perspectives on our company and the broader reinsurance industry
- Training and social activities will be structured into the program, allowing for networking opportunities with peers and colleagues

Description

This role will allow you to gain exposure to the Underwriting function responsible for multiple business lines including Mortgage, Aviation, Marine & Energy, and Surety & Credit within TransRe. The Intern's projects and learnings will include, but not be limited to:

- Surety
 - Loss study performed across all claims to track / assess actual PML's (Probable Maximum Loss). The exercise will involve determining losses as a percentage of limits across the portfolio.
 - Special Acceptance – actual submission(s) / case study review
- Aviation
 - Portfolio exposure analysis (assist in updating global aggregations / tolerances). The reports are utilized for internal / external risk management and retrocession purposes.
- Mortgage Risk
 - Mortgage Analytics Platform (MAP) – data testing
 - TransRe Underwriting Manager Agency (TRUMA) – client accounting reports (verify & reconcile premium accounts / reporting)
 - Mortgage Risk portfolio exposure analysis (loss sensitivity report) – data assessment utilizing our internal 'loan cube'
 - Submission / live deal review – case study

Requirements

- Having taken college-level financial or economics related courses
- Strong analytical skills to analyze contracts and data
- Strong interpersonal skills to present to management and meet with clients/brokers
- Availability to participate in the entirety of the 10-week program
- Ability to work in-person at our offices located at 165 Broadway, New York, NY 10006
- Regular, private and secure access to a computer for remote workdays
